The Similarity of its first Socialist Constitution between China and Hungary

Although, there is a long distance between China and Hungary. However, the similar political system and the strong influence of Soviet Union in the socialist period made the Constitution of People's Republic of China and the Hungarian Constitution of 1949 shared a lot of similarities not only in the text and but also in the structure of their first socialist Constitutions.

In this article, the author would like to introduce the similarities in the first Socialist Constitution between China and Hungary. People's Republic of China and Hungarian People's Republic both established in 1949. Nevertheless, the first Socialist Constitution of China was adopted in 1954, five years later the establishment of People's Republic of China, Hungarian Constitution of 1949 was adopted on 18 August of 1949.²

The Background of Adoption of Constitution

In this chapter, the author will introduce the background of the adoption of Constitution between China and Hungary, especially how the legislature in China and Hungary adopted their first Socialist Constitution and its similarity.

Since 1949, Chinese Communist Party established People's Republic of China, and published the first Constitution in 1954.³ Before the procedure of adopting a socialist

Constitution, the country had elected its Deputy of National People's Congress. On 15 September 1954, the first National People's Congress was hold in Beijng. 1226 Deputies of National People's Congress were indirectly elected by Chinese people.⁴ In the same day, Liu Shaoqi introduced the draft version Constitution to National Peoples' Congress, Deputies read and discussed the new Constitution in the following days and finally passed it with secret ballot on 20 September 1954.⁵

It should be admitted that before the adoption of Constitution of People's Republic of China, this socialist regime ruled this country nearly five year, however, in this new born country there were not an official legislature and Constitution. The provisional legislature was Chinese People's Political Consultative Conference, and the provisional Constitution was "Common Program of The Chinese People's Political Consultative Conference". After five years governing, the majority part of China was organized and peaceful, especially the election of First National People's Congress was strongly support the formation of first Constitution in China. The election for the Deputies of National People's Congress was held in August 1954 in the whole country, and this election elected 1226 deputies in total. Among these Deputies, 668 Deputies were Party member and 558 Deputies were not. The Party member accounts for 54.5 percent of total Deputies of National People's Congress.8

In Hungary, after the Second World War, although Hungary was independent, this country was mainly controlled by the Allied Control Council. In Hungary, the Communist Party was one of the most active Parties even though the Communist Party was not big. In 1945 November, the parliamentary election was held, however, the Smallholders Party won this election, it took 245 seats in total. Nevertheless, with the national wide propaganda, the Communist Party of Hungary gradually won the support from people, in the Parliamentary election in 1949 the Hungarian Working People's Party won 285 seats. And it accounts for 70.90 percent of total Parliament members. 10

Until now, both countries had their own legislature for Constitution, also the majority legislature members were Party member of Communist Party. Therefore, there is no doubt a Socialist Constitution would be adopted in China and Hungary.

The Similarity of Regulations in the Constitution

Since People's Republic of China and Hungarian People's Republic had the same political system, and Soviet Union was the first Socialist country in the world. Following the Soviet model became an obviously rule in these new born socialist countries. They were not only "copy" the political system, but also the economic system and legal system. Therefore, it is easy to find how the shadow of 1936 Soviet Union Constitution in Chinese Constitution and Hungarian Constitution.

In Chinese perspective, this is the first Socialist Constitution in China, it consisted of four Chapters and 106 Articles, also just like the communist countries in East European, Constitution of People's Republic of China had a very strong influence by the Stalin Constitution of 1936. Each level of People's Congress and the relationship between People's Congress and Administrative organs in each lever, which followed the Soviet Union's pattern.¹¹

The first thing will be noticed in Chinese Constitution was the form of state, in the Constitution Article 2 it stipulated that "All power in the People's Republic of China belongs to the people" it stated that this country is ruled by people. There is a very similar regulation in Hungarian Constitution, in Article 2, Paragraph 2 it stated that "In the Republic of Hungary supreme power is vested in the working people" In 1936 Soviet Constitution, which usually considered as the "mother" of Chinese and Hungarian Constitutions, the regulation on the form of state is more radical, "All power in the U.S.S.R. belongs to the toilers of town and country" it stipulated that only toilers are the ruler of this country.

The big different between Socialist Constitution and Capitalist Constitution is the limitation of free market economy. Chinese Constitution and Hungarian Constitution both were Socialist Constitutions. There were some regulations on limitation of capitalism in both Constitutions. In Chinese Constitution Article 6 it declared that "The state sector of the economy is the socialist sector owned by the whole people. It is the leading force in the national economy and the material basis on which the state carries out socialist transformation. The state ensures priority for the development of the state sector of the economy". In Article 8 and 10 the Socialist government claimed its attitude to rich-peasant economy and capitalist economy. "The policy of the state towards the rich-peasant economy is to restrict and gradually eliminate it." "and encourages and guides their transformation into various forms of state-capitalist economy, gradually replacing capitalist ownership with ownership by the whole people. The state prohibits capitalists from engaging in any unlawful activities which injure the public interest, disturb the social-economic order, or undermine the

economic plan of the state."¹⁷ It showed the unwelcome attitude on the development of rich-peasant economy and capitalist economy.

In Hungary, the Constitution also had similar regulations. The Article 4 mainly introduced the policies of economy system in Hungarian People's Republic, in Paragraph 2 addressed the attitude of Hungarian Socialist government on capitalist economy, "In the H.P.R. the directing force of the people's economy is the State power of the people. The working class is gradually eliminating the capitalist elements and is consistently building the socialist order of economy." ¹⁸

In 1936 Soviet Union Constitution, it also stipulated its attitude to the capitalist economy and in consideration of the publishing year of this Constitution. ¹⁹ The Chinese Constitution in 1954 and Constitution of Hungarian People's Republic both had a strong influence by the 1936 Soviet Union Constitution.

For a more detailed examining in the legislature organ, according to the Constitution between China and Hungary, there were also a lot of similar regulations. In the Constitution of People's Republic of China it regulated "The National People's Congress of the People's Republic of China is the highest organ of state power." and in the next Article it stated "The National People's Congress is the sole organ exercising the legislative power of the state." In Hungary the legislature organ is National Assembly, and it also considered as the supreme organ in the state. It is also very interesting that since the Constitution was adopted in China, from 1954 to 1975, the validation period of the first socialist Constitution in China, there were elected 3 sessions of chairman of National People's Congress of China, and all of the Chairman was member of Chinese Communist Party. In Hungary, from 1949 to 1970s, all of the leader of National Assembly, the Speaker, also was the Party member of Hungary.

The Similarity of the Structure of Constitution

The structure of the first Socialist Constitution in China and Hungary also had a strongly influence by 1936 Soviet Union Constitution.

There were five parts in Constitution of People's Republic of China. They were the Preamble, General Principle, The State Structure, The Fundamental Rights and Duties of Citizens and The National Flag, the National Anthem, the National Emblem, and the Capital.²⁵ In Hungarian Socialist Constitution, it seems there were much more Chapters than Chinese Constitution, however it can be concluded four parts as above from these Chapters. There were 11 Chapters in Hungarian Socialist Constitution, the first two Chapters was the General Principles, from Chapter 3 to Chapter 7 it stated the Structure of the State, Chapter 8 was the Rights and Duties of Citizens and Chapter 10 was stipulated the Emblem, Flag and Capital of the People's Republic. Chapter 9 is Fundamental Electoral Principles.²⁶ In 1936 Soviet Union Constitution there was a similar Chapter, which was the Chapter 11, The Electoral System in Soviet Constitution.²⁷ In Chinese Constitution, there was not special Chapter of election system, however in Article 23, 56, 57, 59 and 86 these Articles regulated the election principles in China.²⁸

The Similarity of its first Socialist Constitution between China and Hungary

(Summary)

People's Republic of China and Hungarian People's Republic were far away in geographical, however the political system and legal system were quite similar since they had the same "teacher", Soviet Union. In this article, the author examined the similarity of first Socialist Constitution between China and Hungary. It can learn how socialism applied in different country with a similar standard, the "Soviet standard". However, in practice, there was still have quite different between Chinese Constitution and Hungarian Constitution. In general, Chinese Constitution was less excised in practice, even though the regulations between these two Constitution shared a lot of similarities.
